Pollution Monitoring Survey:

- A pollution detection control camp was organised for two months during (February, March '82) where in Krishna river basin from its origin to Karnataka border was monitored and the effect of domestic and industrial.
- 2. waste load on Krishna water quality was assessed.
- Characterisation studies of sugar factories, pulp & paper mill waste were carried out individually in collaboration with central water pollution control board.
- To assess the recent pollution river in Krishna river continuos monthly water analysis is being carried out from samples at strategic points from a river stretch between Karad to Sangli.
- Survey of water and soil quality in the area irrigated by industrial effluent.
